Charles Kreidler provided information.

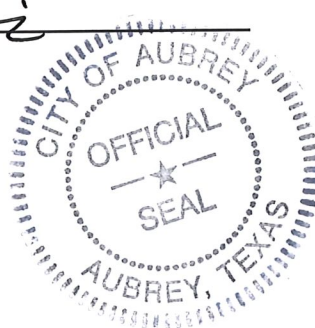
Council Member Erin Allen made a motion to Approve. Council Member Jeff Perry seconded. Motion Passed (4:0).
